1. Grant of Rights

The Model hereby irrevocably grants and assigns to **DADDY G JONES** and its legal representatives, licensees, and assigns the unrestricted right and permission to create, use, reproduce, publish, exhibit, sell, and distribute photographs, videos, and other visual or audio content featuring the Model (collectively referred to as "Content").

This includes nude modeling, erotic performances, and sexually explicit scenes created for the Company's branded platforms including—but not limited to—**OnlyFans, official websites, and social media accounts**.

2. Consent to Nude and Erotic Content

The Model acknowledges and gives full, informed consent to appear fully nude and/or engage in sexually explicit acts on camera, with the understanding that the Content will be used commercially for erotic entertainment purposes.

The Model understands the nature of the work and confirms their participation is voluntary, professional, and compensated.

3. Use of Likeness

The Model grants the Company the right to use the Model's image, voice, likeness, performance, and name (if applicable) in all Content, and to reproduce or distribute said Content in any medium or platform, now known or developed in the future, **worldwide and in perpetuity**.

4. No Takedown Policy

The Model **expressly understands and agrees** that once this Release is signed, **no content will be removed, taken down, or altered** upon request, under any circumstance. All rights to the Content are transferred to **DADDY G JONES**, who retains full ownership and control of how, where, and for how long the Content is used.

5. Legal Age and Identification

The Model affirms they are at least **eighteen (18) years of age**, have provided valid government-issued identification, and are legally allowed to participate in the production of adult content.

False statements or misrepresentation of age will result in immediate termination of any agreement and potential legal action.

6. Compensation

The Model acknowledges receipt of payment or other agreed-upon compensation for their participation. No further royalties or fees will be due from future use of the Content.
